

FOUR WOMEN AMONG THEM

8 Maoists killed in Chhattisgarh encounter

EIGHT SUSPECTED Maoists, including four women, were killed in an encounter in Bijapur district of Chhattisgarh Thursday.

Senior police officers said two INSAS rifles were among the weapons recovered, indicating that the Maoists involved in the exchange of fire were high-ranking cadre. They said the security forces had not suffered any major injury.

Earlier this year, 18 Maoists were killed in two separate encounters in Bijapur district. While those operations were led by the Greyhounds, Telangana Police department's anti-Naxal unit, with the Chhattisgarh Police playing a supporting role, Thursday's operation was ex-

cuted by the Dantewada District Reserve Guard and the Special Task Force, both units of the Chhattisgarh Police. Confirming this, P Sundar Raj,

DIG (anti-Naxal operations) said: "The encounter took place in the area between Timenar and Pusnar, along the border of Dantewada and Bijapur districts. Eight

bodies of Maoists have been recovered, including four women."

Senior police officer said two INSAS rifles, two .303 rifles and a 315 single shot rifle were recovered. "Identification will happen once the security personnel are able to bring the bodies back to Dantewada... However, it is clear that high-level Maoist cadre were involved in the exchange of fire, as INSAS rifles have been recovered," he said.

Senior police officers told *The Indian Express* that close to 400 personnel of the DRG and STF had left for Timenar area, following an intelligence tip-off.

"The spot where the firing began is on the other side of the Bailadila mountain, where the Bijapur district limits begin. The teams reached in the early hours

of Thursday, and the Maoists unions opened fire a little before 6 am. The exchange of fire lasted for over an hour-and-a-half," said a senior police officer.

"Seven bodies were recovered initially, but there was intermittent firing, so reinforcements were rushed to the spot. Later, during a search operation, an eighth body, of a woman cadre, was found. We believe the Maoist teams that were involved in the firing were from the Bhairamgarh and Gangaloor area committees," he said.

Union Home Minister Rajnath Singh called up Chief Minister Raman Singh in the afternoon. A statement released by the state's department of public relations said the Home Minister "congratulated" Raman Singh for the successful operation.

J&K police to get body cameras

THE JAMMU and Kashmir (J&K) Police is set to procure "body cameras" for its personnel as part of its "smart policing" initiative, with the twin purpose of strengthening security and increasing transparency.

"The J&K Police force is about 90,000 strong, so the body cameras can't be available for everyone. They will first be provided for law and order personnel and the traffic police," said DGP SP Vaid. IGP (Kashmir) S P Pani said

the cameras would be mounted on the uniforms as a "visible interface between citizens and law enforcement". Saying this was a major step forward, he said: "This is a civic measure aimed at increasing accountability within the force. We are training our boys for using this."

The CRPF, which has been using body cameras in the state for over a year, considers it an "effective measure". "What this does is that it keeps recording and transmitting to the ops room. So, during operations, it helps guide the forces on the

ground and also helps in analysis, after the operation or the law and order situation is over," said IG CRPF, Zulfiqar Hassan.

In a related development, police stations in the state are being connected via the Crime and Criminal Tracking Network and Systems (CCTNS). According to senior officers, 78 of the 86 police stations in Kashmir zone are already part of the new system. The CCTNS is a Central project aimed at creating an integrated system for effective policing through e-Governance, and is implemented by the National Crime Records Bureau.

Indo-Pacific must be free, open, inclusive region, says Sushma

ASSERTING THAT Indo-Pacific must be a "free, open and inclusive" region, India on Thursday said there was an imperative need for eschewing protectionism and avoiding return to great power rivalries.

External Affairs Minister Sushma Swaraj, delivering the keynote address at the 'Delhi Dialogue' in the presence of 10 delegation heads of ASEAN countries, said a common, rules-based order must be followed in the region that takes into account the equality of all, irrespective of size and strength. Her remarks come amid growing

Chinese assertiveness in the region. "Our vision of the Indo-Pacific not only involves physical inter connectivity but also

entails building bridges of trust, based on mutual respect, giving due regard for sovereignty and territorial integrity, consultation, transparency, viability and sustainability," Swaraj said. She said there was imperative need for eschewing protectionism and avoiding a return to great power rivalries.

"The Indo-Pacific must be a free, open and an inclusive region. We must follow a common, rules-based order, that takes into account the equality of all, irrespective of size and strength. It should allow use of common spaces on sea and in the air," Swaraj said at the 10th edition of the dialogue whose theme was 'Strengthening ASEAN-India Maritime Cooperation'.
